Well, it's that time for rotation again so that we may elect new trusted servants to fill our service positions at Group, District and Area. Area 4 practices a two-year rotation on every even year. All the members at District 8 would like to thank our current trusted servants for their service in the past two years.

The principle of rotation flows from Tradition Two: "For our group purpose, there is but one ultimate authority-a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants; they do not govern." My experience was that, after two years, I had finally figured out what I was supposed to do and it was time to rotate.



# WHO'S IN CHARGE? An Upside-Down Organization

SM F-179 Structure of the Conference

The groups are on top and the trustees at the bottom. Bill W. wrote in Concept I: "The A.A. groups today hold ultimate responsibility and final authority for our world services...." Then, in Concept II, Bill made it clear that the groups "delegated to the Conference complete authority for the active maintenance of our world services and thereby made the Conference... the actual voice and effective conscience for our whole Society."



The inverted triangle of Alcoholics Anonymous service structure is fundamental to our society. To serve—not govern—differentiates AA from other societies. Ignoring this principle for a specific agenda or other exception will invite a cast of unintended consequences ranging from hard feelings to a total compromise of our system, forfeiting our fellowship as we have known it for over 78 years.

The inverted triangle is AA's protection from tyranny. The two risks are the tyranny of the majority and the tyranny of the minority. This inverted triangle prevents the threat of a minority within AA having their rights trampled on. As well, special interest groups can't railroad the agenda.

### The Group... Where A.A.'s Service Structure Begins What Is an A.A. Group?

Partially from pamphlet P-16

The A.A. Group is the heart of Alcoholics Anonymous. Groups are the first contact alcoholics have with A.A. and recovered alcoholics. It is where we gather to share experience and hope. It is also where governance of A.A. begins, with individual members expressing their thoughts and ideas of what and how A.A. should carry the message to still suffering alcoholics. It is where G.S.R.s learn the group conscious.

The long form of Tradition Three clearly states, "Our membership ought to include all who suffer from alcoholism, hence we may refuse none who wish to recover. Nor ought A.A. membership ever depend upon money or conformity. Any two or three alcoholics gathered together for sobriety may call themselves an A.A. group, provided that, as a group, they have no other affiliation."

Further clarification of an A.A. group is found in Concept Twelve, Warranty Six:

- no penalties to be inflicted for nonconformity to A.A. principles;
- no fees or dues to be levied voluntary contributions only;
- no member to be expelled from A.A. membership always to be the choice of the individual:
- each A.A. group to conduct its internal affairs as it wishes it being merely requested to abstain from acts that might injure A.A. as a whole; and, finally,
- that any group of alcoholics gathered together for sobriety may call themselves an A.A. group provided that, as a group, they have no other purpose or affiliation.

Keeping a balance between ultimate authority and active, day-to-day functioning requires **CONSTANT** communication among **ALL** elements of the structure.

# WHAT ARE THE POSITIONS? GROUP POSITIONS

The job descriptions for Group officers are written by the respective Group and may vary from one group to another. Therefore these are general job descriptions subject to individual group decisions.

General Service Representative or GSR represents the group at the District and Area meetings, bringing the groups' activities, thoughts, news and problems these meetings. He or she also chairs the Group's business meeting, coordinates with other group officers and appointed positions like Cake Lady and Supplies.

**Alternate GSR** substitutes for the G.S.R. when the he or she Is absent and unable to exercise the duties. This includes attending District and Area and may require chairing the Home Group's business meeting.

**Secretary** keeps the minutes of the Group and maintains the list of home group members with their contact information. He or she sends out notices and information to members as needed.

**Treasurer** receives contributions from the basket and maintains the financial records of monies received and dispersed; maintains a bank account for depositing all receipts and making disbursements as the Group has determined. A report is made at each business meeting.

## DISTRICT 8 POSITIONS From "District 8 Structure & Guidelines"

**DISTRICT COMMITTEE MEMBER or D.C.M.** conducts all District 08 Committee meetings, which are held quarterly and prepares the meeting agendas and then provides the agenda to the Secretary for distribution. With the Alternate DCM's approval, chairpersons of the District 08

Permanent Committees are appointed. Working with the GSRs, a two way communication system keeps the needs as well as Area and G.S.O. activities. District funds the DCM to allow attendance at Area 4 Assemblies, including fuel, lodging, and meals.

Alternate DCM assumes the duties of the DCM in the event of his or her absence. He or she also coordinates the Permanent Committees and maintains contact with all groups in District 8, primarily urging new groups and unregistered groups to participate in District functions. When District 8 is assigned a task at Area 4, the Alternate D.C.M. insures volunteers from the District are available to cover our rotating duties at the Area 04 Assembly for registration and making coffee. In addition, the Alternate DCM is able to attend Area 4 Assemblies to help coordinate the attendance of the District committee members at the Area Committee meetings. He or she learns the duties of the DCM to be better prepared to step into their duties in the event of their absence. The District funds the Alternate DCM to budget to allow attendance at Area Assemblies, including fuel, lodging, and meals.

Secretary serves on the Executive Committee and keeps the minutes of the District 08 Committee Member quarterly meetings. These are then timely published to all the groups in the District. A current list of all duly registered District 08 groups, their meetings and G.S.R.s is maintained and provided to the Area Registrar.

Treasurer is one of the most responsible positions at District. This job requires accuracy, attention to detail & accountability. He or she ensures the basket is passed honoring the 7th Tradition and takes custody of the collection. The Treasurer is responsible for protecting District funds.

#### GENERAL SERVICE REPRESENTATIVE

Majority from P-19 G.S.R. General Service Representative

The General Service Representative or G.S.R. is the link between the Group and with A.A. as a whole. The G.S.R. presents the voice of the members, the group conscience, reporting the group's thoughts to the District 8 Committee member, D.C.M., Area 4 Assembly, and the Area Delegate, who passes it to the Conference.

This communication is a two-way street with the G.S.R. responsible for bringing back to the group District 8, Area 4 and Conference actions that affect A.A.'s unity and development. Only when the G.S.R. communicates the group conscience, keeps the group informed and communicates the group conscience, can the Conference truly act for A.A. as a whole.

G.S.R.s learn everything they can about the "Twelve Traditions" and "Twelve Concepts" and are familiar with the <u>Service Manual</u>, <u>Twelve Steps and Twelve Traditions</u> and <u>A.A. Comes of Age</u>, <u>Twelve Concepts for World Service</u>, and the pamphlets "The A.A. Group," "A.A. Tradition – How It Developed," "The Twelve Traditions Illustrated," and "The Twelve Concepts Illustrated."

#### **QUALIFICATIONS**

Experience shows that the most effective G.S.R.s are active in group, service and possibly on a District committee or other service where he or she has encountered situations in which the Twelve Traditions were used to solve problems.

- Usually, prospective G.S.R.s have at least two years of continuous sobriety
- He or she has the time available for district meetings and area assemblies.
- The confidence of the group and an ability to listen to all points of view.

#### **FINANCIAL SUPPORT**

Current experience indicates Groups should provide financial support for their G.S.R. to attend service functions including District 8 and Area 4 Assembly, and other service entities.

#### **DUTIES**

G.S.R.s attend District 8 meetings and attend Area 4 Assembly. They receive the G.S.O. bulletin Box 4-5-9.

G.S.R.s supply their D.C.M.s with up-to-date group information, which is relayed to G.S.O., either directly to the Records department or through the Area registrar updating G.S.O.'s database.

They work with group treasurers to develop practical plans for group support. They use the pamphlet "Self-Support: Where Money and Spiritually Mix."

Further, G.S.R.s participate in District 8 and Area 4 service meetings, and help with planning for area get-togethers and conventions. Following these events, they make reports to their groups for the benefit of those who could not attend.

A Group Conscience is the collective conscience of the group membership. The term "informed" Group Conscience implies that all the pertinent information is identified and has been reviewed. A.A. principles have been consulted, and that all the viewpoints have been heard and discussed before a. Vote is taken. To be fully informed requires the willingness and openmindedness to always hear the minority opinion.

Electing a G.S.R. is not a popularity contest but a serious voting decision, electing the best representative for your group. It is not electing a president, but electing a person who loves A.A. and wants to serve the Group and A.A. as a whole.

## THE ROLE OF THE GENERAL SERVICE REPRESENTATIVE

From District 25, Area 30, Eastern MA

The role of the general service representative, or GSR, is essential to the purpose of general service.

Bill W. wrote in Concept I of The Twelve Concepts for World Service: "The A.A. groups today hold ultimate responsibility and final authority for our world services." The role of the GSR is essential to ensuring that groups can fulfill that responsibility. Only when a GSR keeps the group informed and communicates the group conscience can the Conference truly act for A.A. as a whole. This communication is a two-way street, making the GSR responsible not only for bringing forward the group's voice, but for taking back to the group Conference actions that affect the Fellowship's unity, health and growth.

The GSR is the link between the group and "A.A. as a whole." Importantly, this also gives the group a voice in the affairs of the Fellowship. The GSR is that voice.

When the GSR is present at District and Area assemblies, the Group's voice is heard.

When the GSR participates, the

Group's voice is heard.

When the GSR votes, the Group's voice is heard.

#### THIRD LEGACY

## Partially From "District 8 Structure & Guidelines" pages 5 & 6

A.A.'s **Third Legacy Procedure** is a unique electoral procedure used, as needed, in all elections, regardless of level.

"Going to the Hat" appears to introduce an element of chance or gambling which should depend solely on the judgment of the majority. In practice, however, this method is highly successful in eliminating the influence of factions or parties that seem to thrive on political scenes and campaigns.

- 7.1 The following election procedures were written using the **AA Service Manual**, "Third Legacy Procedure," as a guide.
- A. The District 08 Secretary calls the roll of voting members present. This list is the responsibility of each voting member. They are to sign in with the District 08 Secretary as they arrive at the district meeting on election day. Corrections and additions are added to the list at the end of roll call.
- B. Two (2) non-voting members will be selected as "tellers". Two (2) other non-voting will be selected as "collectors" of ballots and a non-voting member will record and tally votes on the board.
- C. All GSRs and District 08 Executive Committee members are eligible for nomination to District 08 Executive Committee positions for the new term. Each member eligible for nomination will be introduced as their name is written clearly for all voting members to view.
- D. The chairperson asks whether anyone is unable to serve, and if so, that person's name is removed from the list.
- E. Paper and pencils are distributed for written ballots.
- F. Written ballots are cast, collected and given to tellers to count.

- G. Each vote will be recorded on the board beside the candidate's name.
- H. The first candidate to receive two-thirds (2/3) vote is elected.
- I. After the second ballot (assuming no candidate receives the necessary two-thirds (2/3) vote of the first ballot), any candidate having less than one-fifth (1/5) of the total vote will be withdrawn automatically, except that the two (2) top candidates must remain. In case of a tie for second place, the top candidate and the tied second place candidates remain.
- J. After the third ballot, candidates with less than one-third (1/3) of the total vote will be withdrawn automatically, except the two top candidates must remain. In case of a tie for second place, the top candidate and the tied second place candidates remain.
- K. A fourth ballot is conducted. If no candidate has two-thirds (2/3) of the total vote, the chairperson asks for a motion, second and majority of hands on conducting a fifth and final ballot. If the motion carries, a fifth and final ballot will be conducted. If this motion is defeated, balloting is over and we
- got the "hat" immediately. If second place is tied, the top candidate and tied second place candidates remain. If there is no tie, the candidate with the smallest total is dropped
- L. If no election occurs by this time, the chairperson announces the choice will be made by lot, from the "hat".
- M. Lots are then drawn by the teller and the first name drawn out of the "hat" is elected.
- 7.2 Currently serving GSRs, incoming GSRs and executive committee members shall elect a District 08 Committee Member, Alternate District 08 Committee Member, District 08 Secretary and District 08 Treasurer in September of each even year. Their term of service shall be two (2) years beginning January 1 of the next odd year.
