One person drunk or hungover identifying with a sober alcoholic? One of the most difficult things to do is decide I'm an alcoholic and I need help. Perhaps even more difficult is walking into a room where people are hugging, laughing, talking, looking eye to eye, knowing I'm in the wrong place. Thank God there is coffee and maybe something sweet.

Joining the meeting I listen and hear all the differences, all the reasons I'm not an alcoholic. Then someone says something that grabs my attention! A similarity. An 'I did that,' too. My ears open and I hear more similarities: actions I took; drunk driving; being fired; quitting the best job I ever had; losing my family and divorces. WOW! Other people have gone through that and they are TALKING about this stuff!

Then the meeting is over with the Lord's Prayer and these people are greeting me and inviting me back! And there is this guy who offers to help me and we exchange numbers. Why would he want to help me? He told me to call tomorrow at 6:00 a.m. Okay.

That's identification. Feeling a sense of unity with complete strangers, recognizing a beginning kinship with sober alcoholics and wanting what they have. Life.

I was single again and went out drinking with the girls. That became a habit that was fun and I enjoyed it. Well, as time went on, I moved back to New Hampshire, lived with my parents and got a job. In 1982 my dad went on a 60 day drunk. No one knew where he went. My mom had contacted the police who issued a BOLO on him and searched for him the whole time. Eventually dad went to treatment in Ocala FI.

When I was 16, dad and mom went on a vacation and this is where it all really started. I was with a bunch of friends on the bank of a river drinking and having a ball. By the end of the night, I had my head hung over the tailgate of my truck throwing up. I thought that was cool.

I very rarely drank through high school because my dad was sober; he could smell alcohol a mile away, especially on my breath. It was a women's meeting using <u>Alcoholics</u> <u>Anonymous</u>. I asked "how does the calorie thing work for drinks with alcohol?" A woman approached me and explained she went to AA meetings and invited me attend with her.

At the A.A. meeting they talked about drinking and problems it causes. A woman said she would be my temporary sponsor for the next 30 days and we would do steps 1, 2, and 3. I quit drinking!

In the first meetings I heard all different where horrible things had happened, loss of relationships, loss of jobs, DUIs and even jail time. None of those things had ever happened to me! So how bad could my drinking have been? Was I really supposed to be in AA?? My sponsor told me that alcohol was only the first half of the first step and everything else had to do with how to live life.

We talked about God and bringing Him into my life and talking with Him. I told her that I believed in God, but God was way too busy to be concerned with me. She shared about trusting in God, depending on God, and having a relationship with God.

So with God, I wrote my resentments, made amends, and cleaned up my side of the street. I also looked at my marriage. He was drinking and I couldn't "fix" him. Divorce #2!.

An AA girlfriend helped me get a job her husband's office, Mountain Valley Spring Water. Before long I was offered a job at headquarters in Hot Springs, Arkansas. My daughter moved with me while my sons stayed with Dad. In 3 months my sons moved in with me.

What more could I ask for? I had a job I loved, my children, and attending A.A. women's meetings, and staying sober. Also, because of the move I needed to find a new sponsor, which I did.

A LETTER FROM BILL WILSON The Use Of The Lord's Prayer At A.A. Meetings, April 14, 1959

Dear Russ,

Am right sorry for my delay in answering...

...Now about the business of adding the Lord's Prayer to each A.A. meeting. This practice probably came from the Oxford Groups who were influential in the early days of A.A. You have probably noted in AA. Comes of Age what the connection of these people in A.A. really was. I think saying the Lord's Prayer was a custom of theirs following the close of each meeting. Therefore it quite easily got shifted into a general custom among us.

Of course there will always be those who seem to be offended by the introduction of any prayer whatever into an ordinary A.A. gathering. Also, it is sometimes complained that the Lord's Prayer is a Christian document. Nevertheless this Prayer is of such widespread use and recognition that the arguments of its Christian origin seems to be a little farfetched. It is also true that most A.A.s believe in some kind of God and that communication and strength is obtainable through His grace. Since this is the general consensus it seems only right that at least the Serenity Prayer and the Lord's Prayer be used in connection with our meetings. It does not seem necessary to defer to the feelings of our agnostic and atheist newcomers to the extent of completely hiding our light under a bushel.

However, around here, the leader of the meeting usually asks those to join him in the Lord's Prayer who feel that they would care to do so. The worst that happens to the objectors is that they have to listen to it. This is doubtless a salutary exercise in tolerance at their stage of progress.

pretty good. Rodeo was a way of life and I really had a great time. I never drank before a rodeo. Afterwards was a different story.

In the spring of 1993, I had an accident and broke my back. This is where my drinking started going wrong. All I could do was sit in the stands and watch as my friends were competing. Sitting in the stands was not good for my disease.

In December of 1993, I married my soul mate and the love of my life. My wife has been there through all the good and bad times. We didn't drink much the first couple of years, mainly because we couldn't afford it.

I retired from my rodeo career in 1996. It wasn't fun any more. My body was taking a beating. I went into sales.

My sales career took off starting with electric motors, then boat sales, food sales, and outboard motors. Outboard motor sales took me to 5 states working boat shows and staying in a lot of motels. I was isolated. I think this is where I crossed that invisible line from a heavy drinker to a full to a full blown alcoholic.

I went through a five day detox and stayed sober for about 2 weeks. Then I was back to the races. Within a year, I was drinking

MANY PATHS TO SPIRITUALITY

"With sharing that reflects the boundless range of belief (and non-belief) among A.A. members — including Buddhism, Islam, Native American faith traditions, and atheism and agnosticism — this pamphlet shows how Alcoholics Anonymous is a spiritual organization, rather than a religious one." (https://www.aa.org/many-paths-spirituality)

This pamphlet was first proposed about 40 years ago, but was repeatedly rejected by one Conference after another. Since it was finally approved by the General Service

Council in April, we hope "Many Paths to Spirituality" will be the welcoming tract to all beliefs.

Interesting that reviews on this pamphlet written by people who are agnostic and atheists are disappointing. As one wrote, "While the intent of the Conference in approving this pamphlet is commendable, the pamphlet itself comes across as totally ignorant of our concerns, if not an outright insult."

Chris G. sums up his opinion with, "Where are the words for those of us who do not believe in mystical gods and powers? Is that supposed to be hidden in "all faiths, beliefs, and practices"? Where is an explicit reference to NON-belief? *Many Paths to Spirituality* fails to speak to the reality of agnostics and atheists in AA who have found sobriety within our fellowship without a belief in God or a Higher Power."

Chris G finishes, "If the Conference thinks that it has satisfied any agnostics and atheists like me, it will find that the pamphlet will add to the problem, rather than being part of the solution."

One of my coworkers and invited me and one of his guy buddies to attend an event. When we picked the friend up, he had been drinking and was somewhat intoxicated. Great !! (said no one ever!) The event was good and the "guy" didn't seem too bad. Uh-oh, you guessed it. I began dating the drinking guy!

My sponsor wanted to know what the hell I was doing for God's sake? I was 5 years sober!! I told her I didn't know! I kept going to women's AA meetings at night. At some point God intervened in his life and one day he went to an AA meeting walking 8 miles to Sellers. He called me at work and told me of the event. That night, after dinner (he'd had a few beers) we went to Sellers. This was my first ever coed meeting! He got a sponsor, got sober and started working the steps.

About a year later a friend invited us to come visit her in Washington State. On that visit, knowing he was a massage therapist, she asked us to move to Washington and have him join her business! So we did. He was a year and a half sober by then. We made the move, kids and all. He started the job. About two months later she moved to be nearer to her kids. We stayed in Washington.

Our kids grew up. We both stayed sober. Four years later after we met, he asked me to marry him. Husband #3! That was 26 years ago.

How did all this happen? God had a plan!!

I was an only child, or so I thought. I learned my mom had been married during World War II and had a son. She had given him up for adoption, so I was not the only child! <u>He</u> found me! We made up for years missed. We had a strong loving relationship. Because he was older than me he acted like a big brother that I never had. Sometimes bossy, but mostly loving and supportive.

more than I did before detox. During this period I totaled 2 trucks.

In May of 2018 I went on a vacation and stayed in a black out for a solid week. I don't remember much, but friends told me all about it.

I was extremely jittery and my brain was exhausted. Was I going to lose my family? I was sick and tired of being sick and tired. The 4 horseman had arrived. I had hit bottom.I was sitting on my living room floor crying, "what am I going to do." I asked God to help me. Right after that prayer, a commercial came on about a treatment facility. I remember this, "if you have a problem with drinking give us a call." And so I did.

I spent 5 days in detox and 28 days in a Treatment center. This is where I was really introduced to Alcoholics Anonymous. We had 4 meetings a day. I had a sponsor before I got home. Come to find out he was also my dad's sponsor. So I guess I'm a legacy in the program.

When I started working with my sponsor I always picked him up and we went to meetings. A lot of meetings. At our home group meetings, we always got there about an hour early, made coffee and cleaned up the meeting room. I didn't understand at the time but he was teaching me discipline.

Understanding is something that gets better with time. Now I understand what he was teaching me and trusting me with responsibilities.

When I was finished with rehab, they made appointments with a psychologist and a psychiatrist. First I was asked to see them 3 times a week. After about a month, they asked to only come twice a week. At the end of 6 months they told me I was getting more out A.A. than they could possibly offer, so they

released me from their care.

After working the steps, all the promises came true. In God's time, of course.

After a couple of years I was asked to carry the message to inmates in jail. What an honor! Now my service work is carrying me into several facilities. Carrying the message is something I didn't think I would be able to do. I have a major fear of speaking in a public setting, but God is helping me overcome this fear. Carrying the message to the still suffering alcoholic is what helps me stay sober.

Service work is a big part of my sobriety. God is giving me an opportunity to serve in several roles. I'm GSR for my home group and Area 4 Corrections chair. I'm active in all sides of the triangle: Recovery, Unity and Service.

One day at a time serenity and calmness has returned to my life. I still have moments but they are a lot less dramatic and not so often. I try not to react in a negative manner toward anyone or anything.

Life happens!!

This program saved my life, it has shown me a way of life that I never knew. In December my wife and I will be married 32 yrs. That is a blessing.

My heart is filled with joy to share my story.

There is one suggestion to the newcomer: Keep coming back until the Miracle happens.

THE CAMEL

Dr. Bob would explain prayer using the camel as an example:

The camel each day goes twice to his knees. He kneels down in the evening, and the men would unload their burdens. In the morning, they kneel down again, and the men put the burdens back on. The camel picks up his load with the greatest of ease. He walks through the day with his head held high. And stays for that day, completely dry.*

Dr Bob, physician would explain prayer by telling how the camels in a caravan would kneel down in the evening, and the men would unload their burdens. In the morning, they would kneel down again, and the men would put the burdens back on.

It's the same with prayer,' Dr. Bob said. 'We get on our knees to unload at night. And in the morning when we get on our knees again, God gives us just the load we are able to carry for that day."**

ACCEPTANCE

While each step in Alcoholics Anonymous is supported by a prayer, the most powerful prayers for the program are often cited as The Serenity Prayer and the prayers for Steps One, Three, Four, Seven, and Eleven.

The Serenity Prayer is the best-known A.A. prayer often recited at the beginning of each A.A. meeting. This prayer emphasizes a core AA principle, Acceptance. In order to change something, I must first accept its reality — to "accept the things I cannot change."

What things can I not change? I can't change things I've done in the past. I can't change other people. Acceptance.

One of the best A.A.stories in the first three editions of the Big Book, "Doctor, Addict, Alcoholic", and in the 4th edition, "Acceptance is the Answer" is all about, obviously, Acceptance. Dr. Paul O. wrote,

"Acceptance is the answer to all my problems today. When I am disturbed, it is because I find some person, place, thing or situation—some fact of my life —unacceptable to me, and I can find no serenity until I accept that person, place, thing or situation as being exactly the way it is supposed to be at this moment. Nothing, absolutely nothing, happens in God's world by mistake. Until I could accept my alcoholism, I could not stay sober; unless I accept life completely on life's terms, I cannot be happy. I need to concentrate not so much on what needs to be changed in the world as on what needs to be changed in me and my attitudes.""




